Dear HEA Parents/Guardians,

My name is Heidi Solomon, and I am a Speech-Language Pathologist providing speech/language therapy to children at the HEA Preschool. I am a long-time member of HEA and my own children are HEA Preschool alum. If you have any concern about your child's speech or language skills, screening, evaluation, and therapy are available to your child while they attend preschool at HEA. A screening of your child's speech/language skills is free of charge if they are over 3 years old. Children under three can be screened by me for \$50 or they can be tested through Child Find (contact your county Child Find office for further details.) If my screening indicates that evaluation and possible speech/language therapy are warranted, there will be a fee for each. The fee schedule is on the back of this letter.

Children's speech and language skills develop at different rates and sometimes our kiddos need some help achieving these skills. Struggling with speech/language can be very frustrating for young children. Providing early intervention is key in the promotion of speech and language skills.

I value the necessity of children being able to communicate effectively with family members and peers, and use research based interventions while utilizing play-based therapy whenever possible. Children learn best through play so why not make learning to communicate as fun as possible? And with 16+ years of experience as an SLP, helping children with their speech and language skill is my absolute passion!!

**A speech/language screening is free for children 3 years and older.**

**If your child is under 3, the fee for a screening is \$50. Payment will be requested through Ivy Pay, a HIPAA compliant payment platform.**

**If the screening indicates that formal evaluation is warranted, the fees are as follows:**

**Evaluation, written report, and meeting for explanation of results: \$250**

**Thirty minute speech/language therapy session: \$60.00**

**I only accept private pay. I do not bill insurance; however, if you wish to seek reimbursement for the therapy sessions, I will be happy to provide you with the necessary paperwork. Please contact your insurance company to discuss the reimbursement procedure and limits to coverage for speech/language therapy.**
